

EIGHTH MEETING OF THE EUROPEAN UNION - MERCOSUR BI-REGIONAL NEGOTIATIONS COMMITTEE

11-14 November 2002 - Brasília -

FINAL CONCLUSIONS

Negotiators from the Mercosur and the European Union met for the eighth time in the context of the EU-Mercosur Bi-regional Negotiations Committee during 11-14 November 2002 in Brasília, continuing the economic and trade negotiations for the conclusion of the Interregional Association Agreement between the European Union and the Mercosur.

The Brazilian Ambassador to the European Communities, José Alfredo Graça Lima, on behalf of the pro tempore Presidency of Mercosur, and the Director for Free Trade Agreements of the Directorate-General for Trade of the European Commission, Mr. Karl Falkenberg, on behalf of the European Union, jointly opened the eighth meeting of the BNC with statements that strongly reiterated the Parties' commitment to a rapid progress of the negotiations.

They recalled the conclusions of the Negotiators' Meeting at Ministerial Level, held at Rio de Janeiro last July. On that occasion, Ministers and Commissioners discussed the state of the negotiations and agreed to a schedule of meetings for 2002 and 2003, giving a new impetus to the economic and trade negotiations of the Interregional Association Agreement.

Following the opening, the Parties met at separate Technical Groups to work intensively on the proposals. As agreed in the Rio de Janeiro Work Programme, discussions focused on texts on standards, technical regulations and conformity assessment procedures; competition; general rules of origin; intellectual property rights; customs procedures; and dispute settlement. Proposals from both sides were reviewed and substantial progress was made on consolidation of negotiating texts. Both Parties agreed to continue their efforts of consolidating texts, aiming at having a first common draft text of the Interregional Association Agreement for the next meeting of the Bi-regional Negotiations Committee.

Furthermore, the delegations finalised their discussions on methods and modalities for the negotiations on market access on goods, including agricultural products, and for the negotiations on services.

Finally, the Parties considered the implementation of the business facilitation measures that were launched during the Second Meeting of Heads of State and of Government of the European Union and of Mercosur, held in Madrid, on 17th May 2002.

The next meeting of the Bi-regional Negotiations Committee shall take place, tentatively, on 17 to 21 March 2003, in Brussels, in conformity with the Rio de Janeiro Work Programme.

ANNEX I

REPORTS OF THE TECHNICAL GROUPS

Eighth Round of Negotiations EU-Mercosur
Brasilia, 11-14 November 2002

TECHNICAL GROUP I

I.1. Tariffs

Methods and modalities for market access on goods

Both sides had a further full exchange on methods and modalities for market access negotiations on goods, allowing for a better understanding on their respective objectives. They finalised their discussions on this topic and recalled that the Rio de Janeiro Work Programme sets a target date of 28 February 2003 for the tabling of WTO consistent offers, with a view to engaging in market access negotiations aiming at achieving significant additional interregional market access opportunities in both agricultural and non-agricultural trade.

Technical issues

Recalling that the EU had presented its market access offer in CN 2001 for processed agricultural products, industrial products and fisheries, and in CN 2002 (basis HS02) for agricultural products, Mercosur requested the EU to provide a correlation table between both nomenclatures. Given that the EU stated its intention to present an updated offer in CN 2002, and that European trade statistics available are not listed in that Nomenclature, Mercosur also requested that these statistics be updated to CN 2002. The EU delegation agreed to provide such information, including trade statistics for 2001.

The EU delegation also agreed to forward an exchange rate correlation table between euros and dollars, for the period 1998-2001.

The Mercosur delegation distributed a list of products of the updated European agricultural offer, in which the conditions for tariff elimination appeared to have changed to longer-term schedules, compared to the original proposal. The EU explained the reason was most likely not of substance, but agreed to verify the list of products.

The EU delegation handed over an inventory of trade statistics received from Mercosur and requested completion and update of these statistics in standard format. Mercosur agreed to submit 2001 statistics for Brazil and Argentina and 2000 statistics for Uruguay and Paraguay. It was agreed that the 2001 statistics of the latter two countries will be submitted as soon as available.

It was also agreed that Mercosur will present its updated tariff elimination offer in NCM 2001 (basis HS96). Whenever possible, Mercosur would present its offer in NCM 2002 and a correlation table between NCM 2001 and NCM 2002.

I.2. Customs Procedures

Delegations conducted a thorough exchange of views on the basis of the revised European Community Proposal for the section on Customs and Related Matters of the chapter on Goods of the Mercosur-EU Agreement (Doc EU-MERC/TRADE/W/1098). As a result, having identified a

common view on the general objectives of the section, it was possible to prepare a working document that reflects the preliminary positions of both parties.

It is understood that, given the short time since the proposal was received, Mercosur may present additional proposals or reactions to the text under consideration.

Delegations agreed to examine the situation with regard to previous negotiations between Mercosur and the EU on the establishment of an agreement on mutual administrative assistance on customs matters and to include the issue in the future work of the BNC on customs matters, with a view to concluding such an agreement .

Both Delegations presented a very positive assessment of the results of the VIII BNC in the area of customs matters and expressed satisfaction with the opportunity to identify areas of convergence and to clarify respective positions where it has not yet been possible to reach a common ground.

I.3. Rules of Origin

The Parties analysed the integrated negotiating text on rules of origin (EU - MERCOSUR/TRADE/1082 rev.1 (16.10.02) based upon the texts previously submitted by the EU and Mercosur, and achieved a common text on some articles.

It was agreed that further analysis of the text is needed in order to continue discussing the subject, especially concerning the following issues:

- Proof of origin (Issue of Certificates and authority responsible for issuing and checking them)
- Verification of Proof of Origin
- Customs procedures related to origin
- Value (CIF, FOB or ex-work) that shall be used by the Parties within the realm of the agreement
- Origin of sea-products
- Origin of products manufactured from non-originating products subject to drawback or other exemption from customs duties.
- Free Zones
- Minimal Operations

The Common Integrated Negotiating Text on Rules of Origin is attached.

I.4. Standards, Technical Regulations and Conformity Assessment

Both Parties exchanged their views and proposals on this chapter from an original side-by-side text and reached a consolidated version, with some brackets to be further discussed and clarified, which is attached.

The Parties agreed that discussions on the possible creation of a Special Committee on Standards, Technical Regulations and Conformity Assessment will take place when the Parties undertake negotiations on institutional framework matters.

The Parties agreed that aspects of technical co-operation under the chapter Standards, Technical Regulations and Conformity Assessment will be discussed in the next round.

TECHNICAL GROUP II

II.1. Services

The meeting ³/₄ held in Brasília, 11-12 November 2002 ³/₄ took place in an excellent spirit of cooperation. Both parties agreed that this 8th round of negotiations provided an excellent occasion to further discuss very important themes of the services negotiations.

Based on Mercosur's and EC's proposals on Methods and Modalities, both sides agreed on a final document on Methods and Modalities for Services negotiations, which is attached.

Mercosur asked for clarification about some of the answers the EU had provided for Mercosur's questions. The clarifications were very useful and both parties agreed that some issues would deserve future in-depth discussions.

In relation to the draft of the future services chapter of the birregional negotiation, there was a broad conceptual discussion on the general objectives of the agreement on services, as well as on some specific aspects of the text. The EC considers essential to agree on the basic rules for the preparation of the initial offers. Mercosur understands EC's preoccupation and reiterates its commitment to the Work Programme agreed in Rio de Janeiro.

II.2. Intellectual Property Rights

Both Parties made presentations of their respective proposals. The proposal by Mercosur was handed over to the European Union in March 2002, while the European Union presented its proposal in October 2002. Both were included in a side-by-side document (annex).

Mercosur reiterated its understanding that the bi-regional talks are not the appropriate forum for discussing the accession to international treaties. The European Union stressed that an Agreement of this nature requires a high level of protection of intellectual property which would be effectively obtained, inter alia, by adhering to previously negotiated treaties.

Both delegations acknowledge that the European Union and Mercosur countries already grant high levels of protection to intellectual property rights. However, the European Union delegation also considered that there is scope for improvement and that the Agreement should leave flexibility to welcome future developments.

The delegations upheld a discussion and exchanged opinions and arguments with special attention to topics in which distinct approaches prevail, such as standards of protection, scope of the chapter, public health, biodiversity, enforcement, review mechanisms, protection of plant varieties, geographical indications, most-favoured nation clause and transfer of technology.

The delegation of the European Union expressed its willingness to promote technical co-operation and to assist Mercosur in the field of enforcement of intellectual property rights.

The delegation of the European Union expressed its intention to present a document containing its preliminary comments on the side-by-side document, based on the discussions held during the meeting. The delegation of Mercosur expressed its disposition to offer written comments to the European Union document, thus establishing a basis for a consolidated text, to be presented in the next round where intellectual property will be part of the agenda.

TECHNICAL GROUP III

III.1. Competition

The working document of this session was the consolidated text for competition presented by the European Community (EU-MERC/TRADE/W/1067Rev.1 Corr1 18.10.02).

The delegations performed a detailed revision of the above mentioned document and, as a result, it was possible to progress towards a more convergent text. Concrete progress on a number of issues should be highlighted, such as the agreement reached on Article 4 "Coordination of enforcement activities", the approximation of views on Article 3 "Notification" and that both Parties agreed to present revised proposals for Article 6 "Exchange of Information" in order to seek common ground on this subject. With regard to Article 5 "Consultations", Mercosur indicated its willingness to reflect further on its proposal.

Both delegations expressed their satisfaction with the outcome of this eighth round of negotiations and agreed that it might be possible to reach a final agreement for this chapter in the near future.

The resulting consolidated text agreed during this session is attached.

III.2. Dispute settlement

Both delegations agreed that this session's discussion would be based on the side-by-side text prepared by Mercosur on 9 October 2002 (copy attached).

The Parties agreed that the purpose of this round was to clarify their respective proposals, and to identify areas of common ground with a view to preparing a consolidated text for consideration at future rounds of negotiations.

Both delegations explained the main objectives and conceptual framework of their respective proposals and an in depth discussion followed on all the points contained therein. Both Parties shared similar ideas on how the dispute settlement mechanism should function, although there still remained a number of important issues that will need further exploration and consideration.

Both sides agreed that this had been a very useful round of discussions that had enabled a deeper understanding of both proposals. It was also highlighted that there were a number of areas of common ground that could form the basis of a consolidated text. In order to maintain the progress achieved in this round, the EC offered to submit a proposal that would further clarify and simplify the views that had been expressed during the three sessions, and which it considered would facilitate the preparation of a consolidated text. The Mercosur delegation welcomed the EC offer agreed to reflect further on some issues. Both delegations agreed that a consolidated text should be prepared in time for discussion at the next round, and recommended that the Dispute Settlement chapter should be included on the agenda for the March 2003 round in Brussels.

BUSINESS FACILITATION

The Parties had an in-depth discussion on the proposal presented by Mercosur for the implementation of the whole of the measures agreed in the Madrid Action Plan on Business Facilitation. The Parties agree that, in order to respond fully to the expectations of the private sectors put forward by MEBF and of the Governments, the implementation of the Action Plan

must be considered in an integrated and balanced way, so that all specific areas be addressed at the same pace.

The Parties also agreed that Business Facilitation be included in the agenda of the next BNC meeting (Brussels, March 2003). At that opportunity, there will be a specific meeting on this subject in order to deal with the actions agreed on the four specific areas (Sanitary and Phytosanitary Measures; Customs; Standards, Technical Regulations and Conformity Assessment; and Electronic Commerce).

In the field of Sanitary and Phytosanitary Measures, the Commission agreed with the Mercosur proposal of exchanging questionnaires. In this sense, the Parties agreed to exchange them in December 2002. The answers should be made available in February 2003 and thoroughly discussed at the session on business facilitation of the next BNC meeting. Furthermore, the EU agreed with the Mercosur proposal to hold a seminar on SPS issues, with the participation of both the public and the private sectors. Mercosur suggested that such seminar should be held at a date close to the IX BNC meeting. The delegations agreed to exchange their views on date, place and the programme of the seminar, within the next fifteen days. The EU indicated its willingness to explore ways to financially contribute to the organisation of such a seminar.

In the field of Customs, the EC made preliminary comments on Mercosur proposals. A number of measures that can be more rapidly implemented were identified, as well as the availability of funds for their implementation by cooperation.

In the field of Standards, Technical Regulations and Conformity Assessment, the Commission presented a written reaction to the Mercosur proposal (Annex).

In the field of Electronic Commerce, the EC agreed with Mercosur proposal of exchanging information about e-commerce themes on the next BNC meeting. In that opportunity, the Parties shall make presentations on the following themes: the use of electronic contracts; the development of statistical methods applicable to electronic commerce; the consumer protection in electronic means; the liability of intermediary service providers; the treatment of unsolicited electronic commercial communications.; and the recognition of certificates of electronic signatures and the facilitation of cross-border certification services. The Commission also expressed its willingness to examine concrete proposals for projects to implement actions related to electronic commerce, under the cooperation program on information society.

The EU undertook to reply in a consolidated document to all of Mercosur's proposals and will make additional suggestions for the implementation of the measures .

OTHER ISSUES

The Parties agreed on a common system for registration of official documents (Annex II). Documents annexed to these conclusions and previous negotiating text shall be registered accordingly, having as a basis the preliminary inventory of exchanged texts (Annex III).

ANNEX II

Common Registration System

· Considering, on one hand, that the present stage of the trade negotiations between the Mercosur and the EU involves a vast and increasing exchange of negotiating papers between the

Parties, and, on the other hand, the need to facilitate and organise the handling of the texts being examined in the various Technical Groups, the Parties agree to a common system for the registration of working documents, based on the following methodology:

(a) indication of the BNC in which the document will be or has been presented. When dealing with working texts presented between meetings, reference would be made to the following BNC - even if the subject dealt in it is not to be discussed in that meeting. To facilitate the registration, all documents presented between BNCs will be incorporated in the Minutes of the following meeting.

(b) identification of the document's origin (MS for Mercosur and EU for European Union). If the text embodies proposal from both Parties and it is an agreed text, the initials MS-EU would apply.

(c) indication of the initials of the Technical Group in which the text was originated. If the documents are not from a specific TG - i.e. business facilitation - the identification will be made by using identifying initials for that specific area. For example, for Business Facilitation, "BF"; for texts concerning general aspects of the negotiation, "Gen".

(d) numbers indicating the sequential order of the documents. Each series of documents (MS, EU and MS-EU) would have its own sequential order of numbers; and

(e) the date when the document was introduced in the negotiation.

EXAMPLES:

- Revisions or changes in texts already presented shall be indicated by using the initials "Rev". "1", "2", etc underneath the identification of the original document,.

IX BNC/EU/Gen/01/05.07.01

Rev. 3

- For registration purposes, the proposed system would also be used for the documents already formally presented, based on the inventory discussed in the VIII BNC.
