TECHNICAL ADAPTATIONS TO APPENDIX 2 TO ANNEX I TO THE
AGREEMENT

LIST OF WORKING OR PROCESSING REQUIRED TO BE CARRIED OUT
ON NON-ORIGINATING MATERIALS IN ORDER THAT THE PRODUCT
MANUFACTURED CAN OBTAIN ORIGINATING STATUS

THE JOINT COMMITTEE,

Noting that the amendments to the Nomenclature appended to the International Convention on the Harmonized Commodity Description and Coding System (HS) entered into force on 1 January 2007, entailing adjustments to the HS structure of Appendix 2 to Annex I to the Agreement,

Recognising that the technical adaptations to Appendix 2 to Annex I to the Agreement do not constitute a substantial change to the Agreement,

Having regard to paragraph 8 of Article 70 of the Agreement, empowering the Joint Committee to amend the Annexes and the Appendices to the Agreement,

DECIDES:

1. Appendix 2 to Annex I to the Agreement shall be replaced by Appendix 2 to Annex I as set out in the Annex to this Decision.
2. This Decision shall enter into force on the first day of the third month after the last Party has notified the Depositary of the completion of its necessary legal procedures to bring this Decision into force.
3. The Secretary-General of the European Free Trade Association shall deposit the text of this Decision with the Depositary.
