## 13th Round Transatlantic Trade and Investment Partnership Negotiations - 25 till 29 April 2016

### NEGOTIATIONS

The thirteenth round of EU - U.S. negotiations on the Transatlantic Trade and Investment Partnership (TTIP) agreement will take place in New York, NY from 25 till 29 April. The Office of the U.S. Trade Representative (USTR) will host a stakeholder forum on Thursday 28 April from 11:00 – 16:30 to provide an update on negotiations and solicit input and feedback from interested stakeholders, as well as a press conference on Friday 29 April to discuss outcomes from the negotiations.
