All services covered by this Appendix are subject to the measures listed in Costa Rica's Schedules to Annex I and II (Non-Conforming Measures) for Chapter 10 (Trade in Services) and Chapter 11 (Investment) on the basis that it does not derogate from or take away the Services commitments made under this Appendix by Costa Rica to Singapore.

All construction services covered by this Appendix are subject to the measures listed in Costa Rica's Schedules to Annex I and II (Non-Conforming Measures) for Chapter 10 (Trade in Services) and Chapter 11 (Investment) on the basis that it does not derogate from or take away the Construction Services commitments made under this Appendix by Costa Rica to Singapore.

## **Appendix 7 General Notes**

Unless otherwise specified herein, the following General Notes apply to all Appendices of this Annex.

1. Use of lists of suppliers:

Entities listed in Appendices 1 and 3 might use lists of suppliers.

2. Limited tendering:

Notwithstanding Article 8.14 (Limited Tendering Procedures), procuring entities listed in Appendices 1, 2 and 3 might award contracts by limited tendering procedures in the following circumstances:

- (a) If it is strictly necessary for reasons of public interest, duly proven.
- (b) For objects involving qualified security.
- (c) In cases of urgent attention of judicial procedures.
- (d) For conciliation and arbitration services.
- (e) In cases of building and establishment of government offices located abroad, as well as procurement of foreign physical or legal persons that will provide their services abroad.

3. Specific exclusions

This Chapter shall not apply to any procurement made by a covered entity on behalf of a non covered entity.
