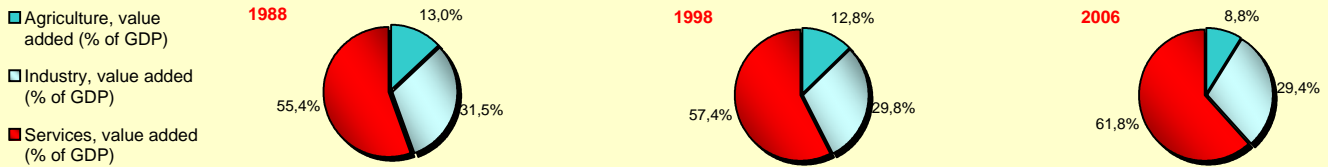

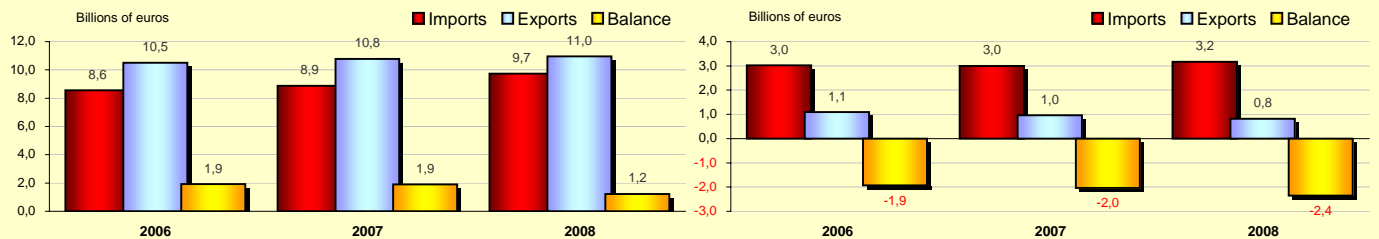

EU27 WITH COSTA RICA



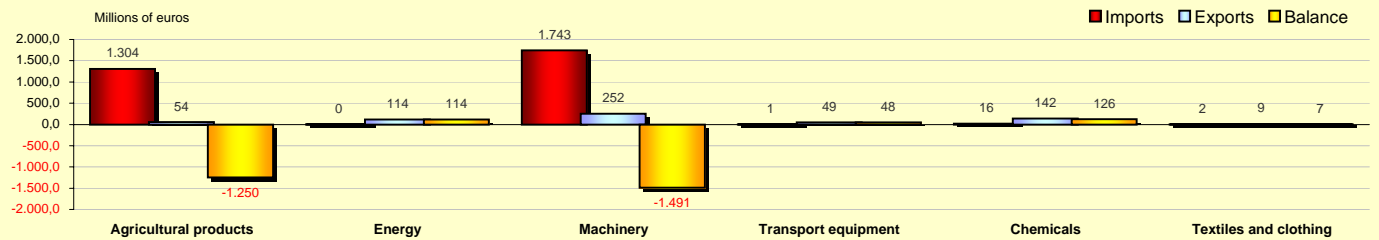

EU27 MERCHANDISE TRADE WITH COSTA RICA BY PRODUCT (2008)

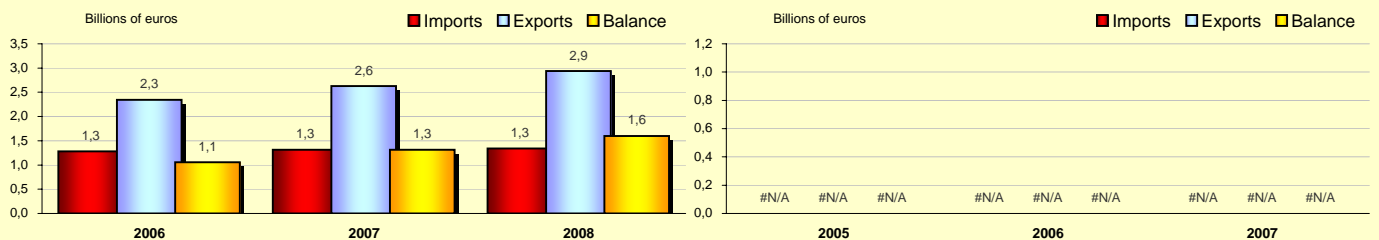

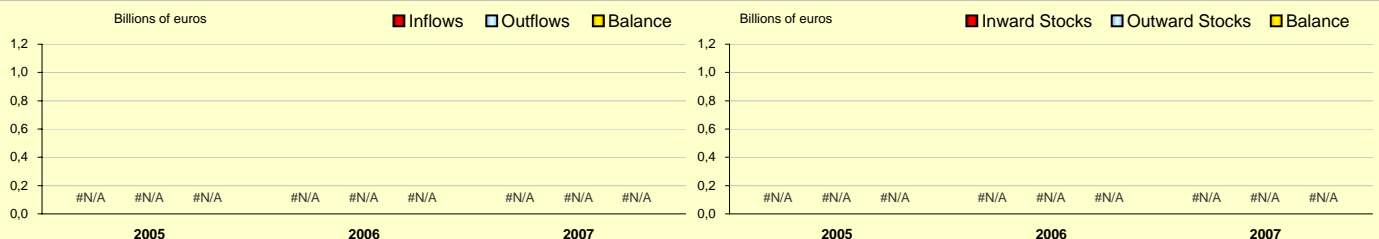

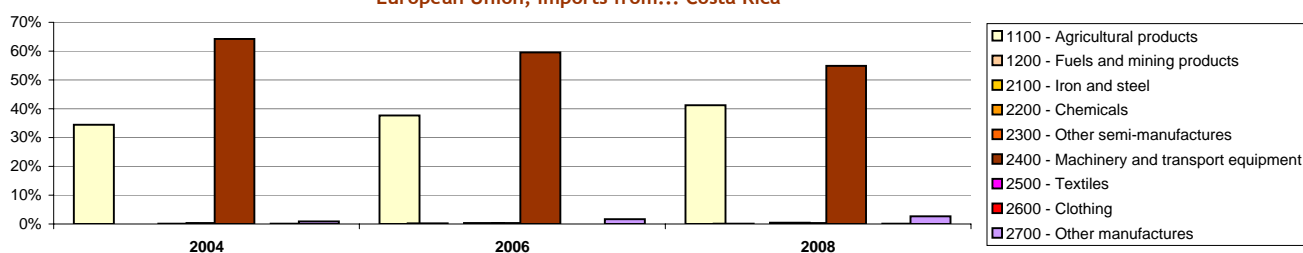
