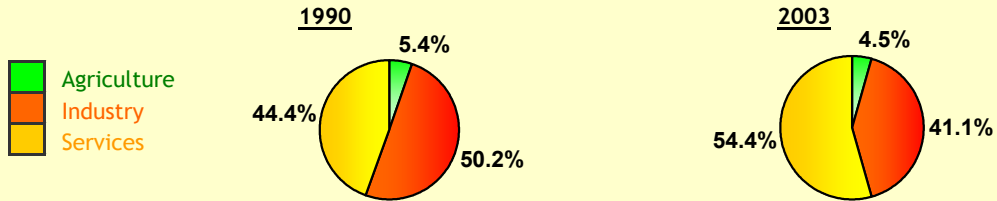

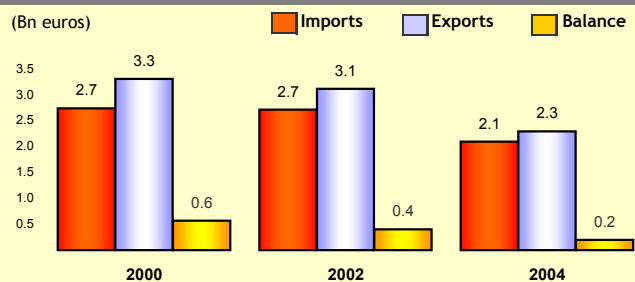

## EU25 MERCHANDISE TRADE WITH VENEZUELA

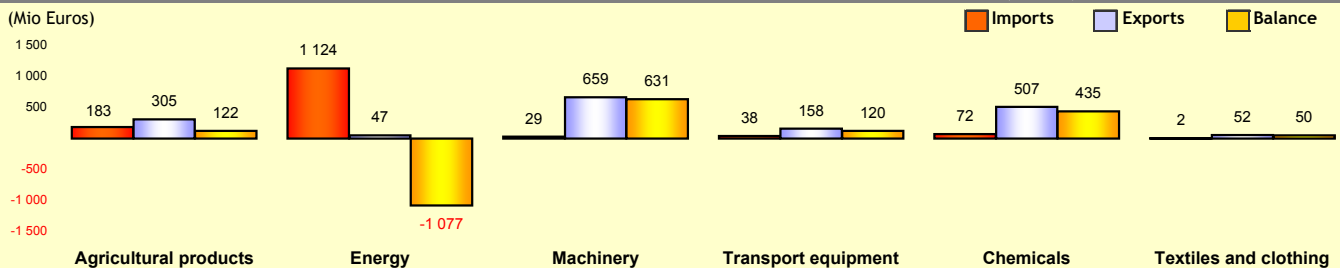

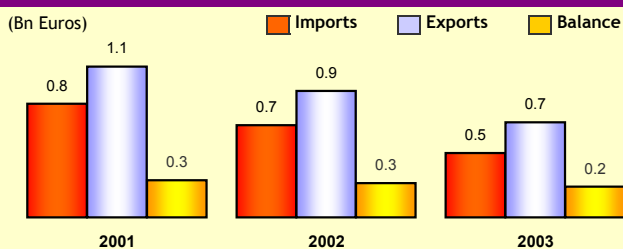

## EU25 MERCHANDISE TRADE WITH VENEZUELA BY PRODUCT (2004)



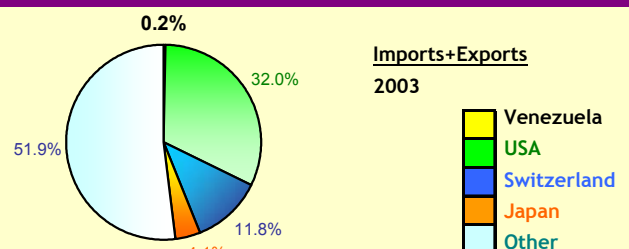

## EU15 TRADE IN SERVICES WITH VENEZUELA

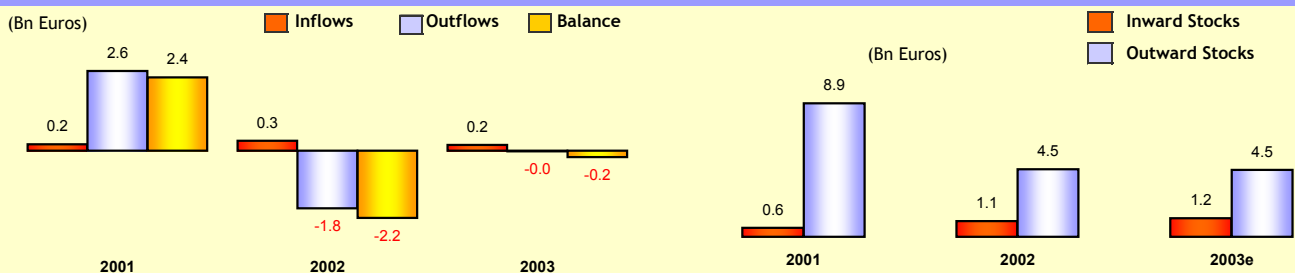

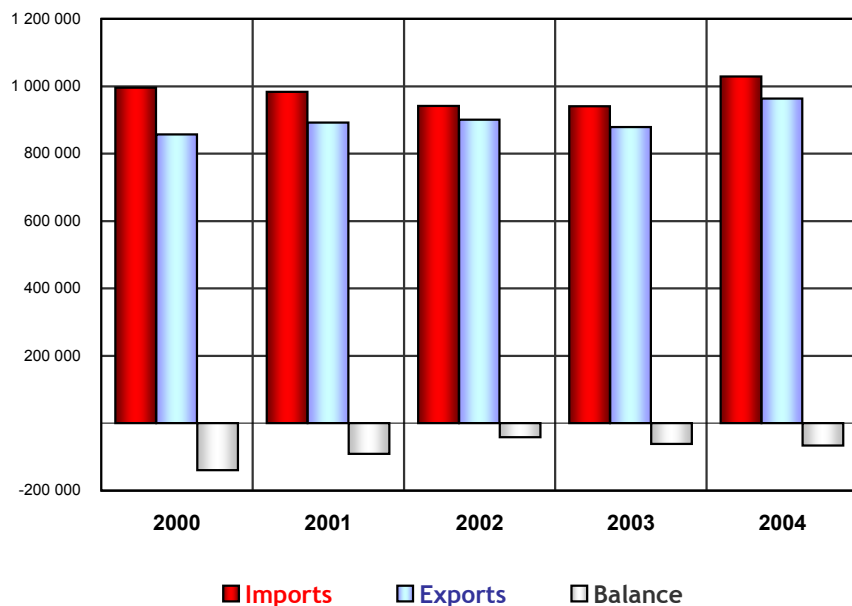

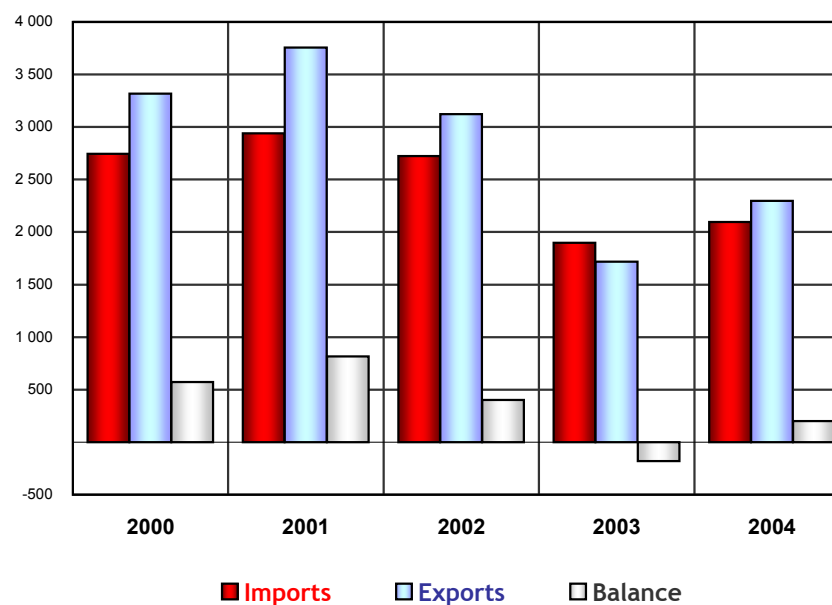

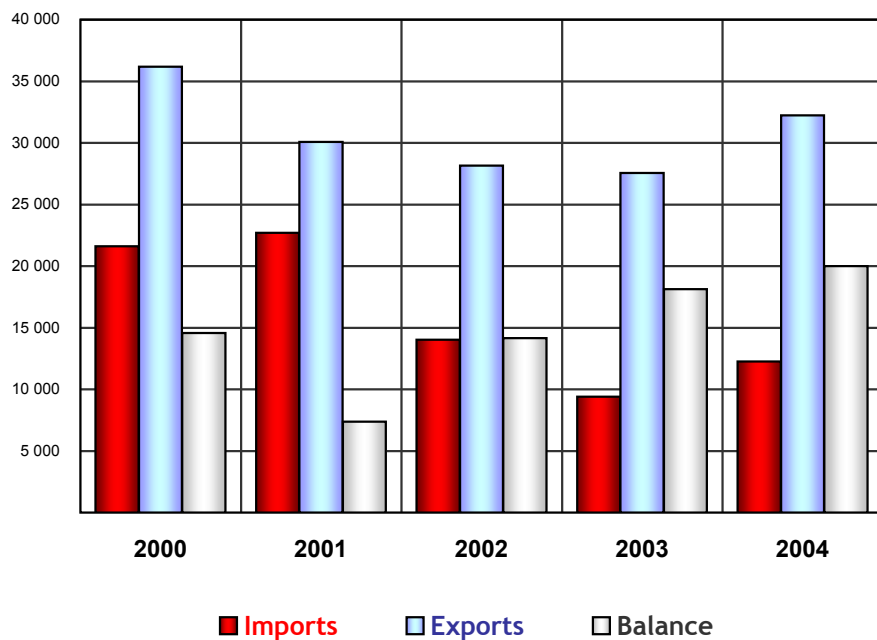

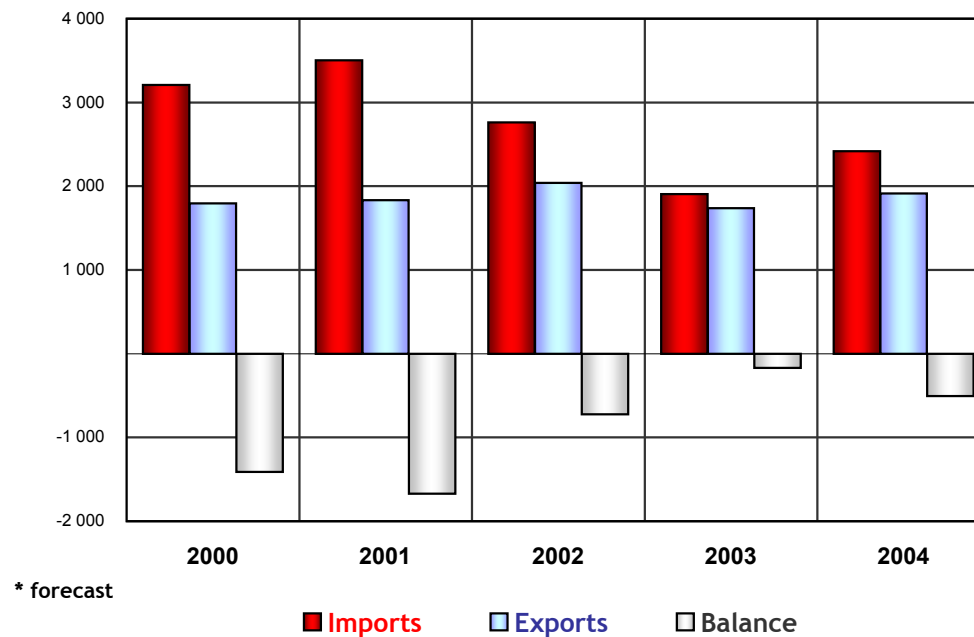

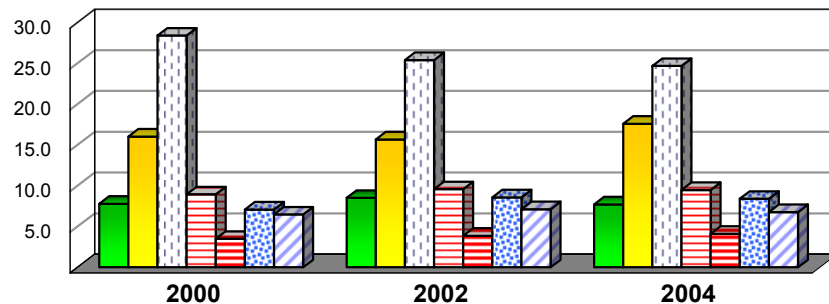

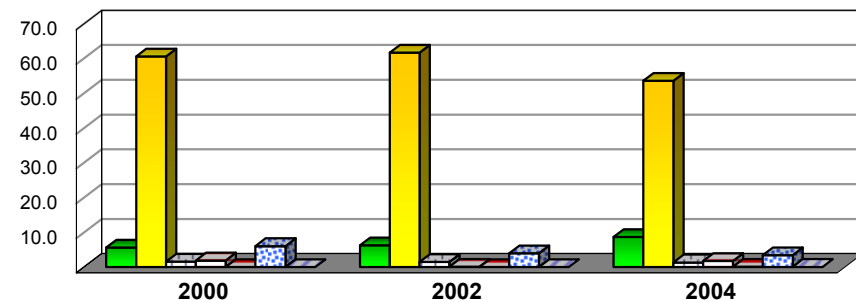

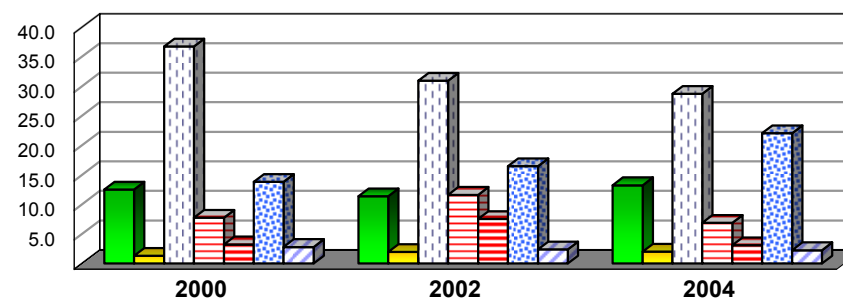
### Structure of Exports (%)

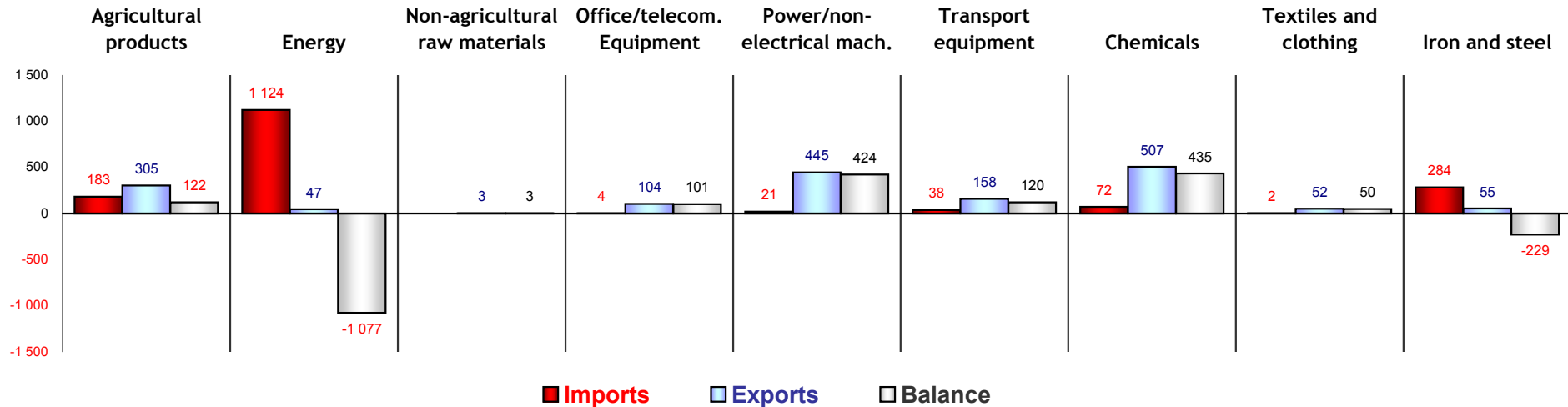
